1. EUROPEAN CHARTER

1) The action of “the meeting points” is founded on recognition from the importance of family ties, and the child’s interest and right, to see assured the setting up and continuity of all relations necessary to the construction of its identity. That is set on the articulation from psy-chological, social and legal dimensions.

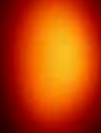
2) All situation wherever the child could not set up or maintain the relation with one of its “ parents”*, affects him in his development, and the construction of its identity.

Some of these situations made necessary, that all persons concerned participate to recognize the problems and conflicts, to speak them, this way the child is set on its story in relation with its origins.

1. EUROPEAN CHARTER

6) This neutral places offer a framework, the physical, psychological and moral security and the appropriate support, allowing relationship's maintenance; it permits the initial contact or the resumption of child-parent relation, between the child and the parent with whom it does not live. This support should consider the specific needs of all persons concerned; consider its culture and rhythm, always respecting children's interest.

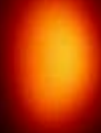

- **“ Children’s long term behavioral and emotional adjustment will be more positive in the long run when they have contact with both of their parents” [Thompson, Amato, 1999, quoted by Birnbaum and Alaggia, 2006)]**
